Salt River and Tributaries

The confluences of the North, Middle, Elk, and South forks of the Salt River come together to form Mark Twain Lake. If you paddle into the arms of the lake, be prepared for slow water and lots of paddling. But these areas do promise plenty of good fishing. There are many more accesses around the lake than are mentioned here. For more information, contact the U.S. Army Corps of Engineers for a lake map. See address on Page 99.

On the east side of the lake below the Clarence Cannon Dam, the Salt River flows for 63 miles to the Mississippi River. A good three-hour float is between the two dams — from Clarence Cannon to the Re-regulation Dam. There you will see a variety of landscapes including bluffs, sandbars, and open fields.



- 9.8 Waterfowl refuge. No boating allowed during waterfowl hunting season.
- 11.3 USACE parking lot on left, south of Route U on Monroe County Road 445. If water is low, boats have to be carried from lot.
- 14.4 Elk Fork Arm of Mark Twain Lake.
- 15.7 Mouth of Jordan Branch. Access is 0.8 miles upstream. Can only be used to launch canoes/kayaks when water is high.
- 16.7 End of waterfowl refuge. USACE parking lot on right, but not good access for boats.
- 17.5 USACE boat ramp on left.
- 23.0 South Fork Arm of Mark Twain Lake.
- 25.6 Hwy. 107 Bridge.
- 29.0 Middle Fork joins with North Fork Arm.



- 7.8 Brush Creek Arm of Mark Twain Lake.
- 9.5 South Fork Recreation Area with boat ramp.
- 10.0 Hwy. 154 Bridge and USACE boat ramp.

Salt River

Difficulty: I and II.
Gradients: general — 1.
Counties: Ralls and Pike.

- 7.0 USACE boat ramp, on left, Cincinnati Road.
- 9.0 Re-regulation Dam. Portage on right. Bluff View Recreation Area with boat ramp below dam on left. For boater safety, the USACE has established a no-boating zone on the Salt River that currently extends approximately 2,000 feet downstream of the Re-regulation Dam to the Bluff View Recreation Area ramp. Paddlers are encouraged to contact the USACE Mark Twain Lake office (573-735-4097) for rules, water levels, and portage options.
